## THE CORPORATION OF THE TOWNSHIP OF ALFRED AND PLANTAGENET

## **BY-LAW NUMBER 2020-36**

## A By-law to amend the waste management By-law no. 2009-55

**BEING A BY-LAW** of the Corporation of the Township of Alfred and Plantagenet to provide for the operation of municipal landfill sites, to establish tipping fees, to provide for curb-side pick-up of waste and recycling, to recover the cost of providing the pick-up and to regulate the manner and amount of waste being disposed of at the landfill sites.

**WHEREAS** Section 11 (3) 3 of the *Municipal Act*, 2001, provides that municipalities may, by by-law, establish, maintain and operate a waste management system.

**WHEREAS** Section 391 of the *Municipal Act*, 2001, authorizes a municipality to impose fees or charges on persons for services or activities provided or done by or on behalf of it:

**THEREFORE** the Council of the Corporation of the Township of Alfred and Plantagenet enacts as follows:

- **1. THAT** Section 1.1 (b) be amended as follows:
  - 1.1(b) "Container" shall mean a 120L receptacle, with an identification number and logo, provided by the Municipality, for the disposal of household garbage or other waste:
- 2. THAT Section 1.1 (e) be added:
  - 1.1 (e) "Tags" shall mean tags available at the Municipality's office for the identification of excess garbage bags, at a cost of 2.00 \$ each;
- 3. THAT Section 2.1 be amended as follows:
  - 2.1 (a) the occupier of a dwelling unit may place only one Container for collection by the Collector; or
- 4. THAT Section 2.1.1 be added:
  - 2.1.1. Every owner of a residential unit in the Municipality is responsible for payment of the initial Container, for an amount not exceeding 50% of the cost of the Container, assembled and delivered;
  - 2.1.2 Every owner of a residential unit in the Municipality will be responsible for 100% of the cost of replacement for damaged, stolen or lost Container;
- 5. THAT Section 3.3 be amended as follows:
  - 3.3 (b) in the case of garbage, all water and excess liquid is drained therefrom and disposed of by the occupier, in the approved Container, and as required under the appropriate environmental regulations;

- **6. THAT** Section 3.3(d) be replaced by:
  - 3.3 (d) any garbage in excess of the content of the approved Container shall be placed in bags not exceeding 13.6 kg (30lbs) and identified with a Tag especially provided at the Municipality for that purpose;
- 7. THAT Section 3.12 be amended to add:
  - 3.12 (s) the Collector shall not pick-up any garbage that is not placed in the approved Container or identified with a Tag as provided by the Municipality;
- 8. THAT this By-law shall come to force and effect on September 15th, 2020.
