
## Notice of Master Plan Township of Alfred and Plantagenet Lefaivre Water Master Plan



The Township of Alfred and Plantagenet (Township) and The Nation Municipality (Municipality) have completed a Master Planning process in accordance with Approach 1 of the Municipal Engineers Association (MEA) Class Environmental Assessment (Class EA) to develop a Water Infrastructure Master Plan. The Master Plan study assessed various options to improve the performance and reliability of the water treatment and distribution systems to ensure they can be relied upon to accommodate current and future flows generated within the Township and the Municipality.

Based on the study findings, input from technical agencies and the public, the Master Plan is now complete. The preferred alternatives include upgrades to the water treatment plant, booster pumping stations, distribution systems and water storage. The recommended projects are presented in Section 6 of the Master Plan report which is available for review at the Township Hall or on the Township's website: <u>Plans, Reports and Studies -</u><u>Township of Alfred and Plantagenet (alfred-plantagenet.com)</u> and at the Nation's website: Announcements & Notices - The Nation
